PARTIES:

Principal : BEWDEN INC., 80 SW 8th Street, Suite 2000, Miami, FL 33131

Agent : NEIL GOSINE, representing N-LUVI CO., 3, Greaves Ave. Princess Town, Trinidad and Tobago.

Commission Structure:

Commission rate : range between 1% to 5% on total FOB origin port, sales value.

Payment schedule: based on confirmed and completed transactions (5 to 7 days after the buyer settle the 100% of invoice amount at seller's bank).

Price Updates:

** BEWDEN INC., will provide updated pricing on FOB origin port when the producers and/or manufacturer release new offers that will be according to availability of product, crop, inventory, new production batches and or any other potential situation for updating prices.

The seafreight rates will be informed once a month, at the beginning of each month according to shipping lines release of sea freight rates.

** The agent is responsible for adding a commission margin before presenting final prices to importers.

Termination:

** Either party may terminate this agreement with 30 days' written notice.

** The Agent must comply with all import regulations and standards in Trinidad and Tobago.
